## Organization / CAN Participation Report

### What are the changes?

The list of agencies that participate in the CT Homeless Management Information System (CT HMIS) changes throughout the year, and in an effort to keep the list up to date so that clients and staff can confirm who is active, a report has been added to CaseWorthy to display all active agencies in the CT HMIS system as well as their participation in each Coordinated Access Network. Additional information on data-entry and user counts/activity is also available.

### Which users are impacted?

This view is available to all organizations under all CT HMIS roles.

To access, go to the Admin Tab > Reporting > Operational Reports > CT HMIS Administration Section > Organization / CAN Participation

### How does this help?

Agencies will be able to:

- Provide clients a list of which organizations are participating in the CT HMIS database, as referenced in the release of information (ROI)
- Review general HMIS activity
- See in which CANs the organization has an active program
